TERMS & CONDITIONS CAMELOT EUROPE

It is really important that you read and understand these terms and conditions as they contain valuable information and legal facts which will govern our relationship with you.

These terms and conditions have been developed because we want you to feel confident about the privacy and security of your personal information entered on our website. We follow strict security procedures in the storage and disclosure of your information as required by law. Our security procedures mean that we may ask for proof of your identity before we will disclose information about you, or to you, be this on our website via email or over the telephone.

We reserve the right to amend or modify these terms and conditions at any time and in response to changes in applicable data protection and privacy legislation.

HOW WE USE YOUR PERSONAL DATA

Registering with Camelot is free of charge without any obligation. Your personal information is used for the vetting and recruitment of Guardians or Users in Camelot managed properties. The personal information you provide is also used to notify you of new properties under management, news, offers and research. Camelot may use the phone number you have submitted to contact you about available properties and services related to the properties. Your e-mail address will be used to keep you updated about the selection procedure, to invite you for an interview, or to inform you about any news or offers of Camelot or a company affiliated with Camelot. Camelot may contact you with invitations to view properties that you have not selected, of which Camelot believes will suit your search. By using our website you are giving us permission to use your data in this way.

USING DATA FOR RECRUITMENT AND SELECTION

For your application we will use the data you have submitted, based on that data we may invite you to an interview for temporary living and/or working in a Camelot managed property. A credit check may be part of this selection procedure. The contracts we use are, amongst others,
